19 Q AND, IN CONNECTION WITH YOUR DUTIES AS RESIDENT
20 MANAGER, DID YOU COME IN CONTACT WITH AN INDIVIDUAL BY THE NAME
21 OF ALEXANDER CAMERON?

22 A YES, I DID.

1 Q ALL RIGHT.

2 AND, IN FACT, HE OCCUPIED ONE OF YOUR APARTMENTS?

3 A YES, APARTMENT 513.

4 Q PARDON?

5 A APARTMENT 513.

6 Q AND, WILL YOU TELL ME -- I TAKE IT THAT IS ON THE
7 FIFTH FLOOR?

8 A YES, IT IS.

9 Q CAN YOU TELL ME DURING WHAT PERIOD OF TIME, APPROXI-
10 MATELY?

11 A OKAY. IT WAS FROM APRIL OF '86 TO AUGUST OF '86.
