THE COURT: ARE YOU READY TO BRING THE JURY BACK?

MR. KLOCH: YES, SIR.

THE COURT: BRING THEM BACK.

(WHEREUPON, THE JURY ENTERED THE COURTROOM.)

THE COURT: MEMBERS OF THE JURY, LAST EVENING AFTER YOU LEFT, THE COMMONWEALTH, BY MR. KLOCH, INDICATED HE HAD COMPLETED HIS CASE. ALL RIGHT. MR. CLARK AND MS. MOORE.

MS. MOORE: I CALL ALEXANDER CAMERON TO THE STAND, YOUR HONOR.

WHEREUPON,

ALEXANDER CAMERON,

DEFENDANT, WAS CALLED AS A WITNESS BY AND IN HIS OWN BEHALF AND, AFTER HAVING BEEN FIRST DULY SWORN, WAS EXAMINED AND TESTIFIED AS FOLLOWS:

DIRECT EXAMINATION

BY MS. MOORE:

Q ALEXANDER, PLEASE STATE YOUR FULL NAME FOR THE JURY AND THE COURT?

A JOHN ALEXANDER CAMERON.

Q AND, WHAT IS YOUR ADDRESS?

A 2225 CHARLOW, FAYETTEVILLE, NORTH CAROLINA.

1 Q DIRECTING YOUR ATTENTION TO FRIDAY, NOVEMBER 28TH, IN
2 THE LATE AFTERNOON AND EARLY EVENING HOURS OF THAT DAY, WHERE
3 WERE YOU?

4 A I WAS DOWN AT MY MOTHER'S HOUSE PLAYING CARDS.

5 Q AND, WHERE IS THAT?

6 A ON PENNSYLVANIA AVENUE IN FAYETTEVILLE, NORTH CAROLINA.

7 Q WHO WERE YOU PLAYING CARDS WITH?

8 A MY MOTHER, A FRIEND OF MINE NAMED BOBBY MCQUEEN,
9 MARVIN, AND, ESPECIALLY, THAT WAS IT.

10 Q WHAT IS MARVIN'S LAST NAME?

11 A MARVIN'S LAST NAME IS NIXON.

12 Q ALL RIGHT.

13 WHAT TIME DID YOU START PLAYING CARDS?

14 A BETWEEN 5:00 AND 6:00.

15 Q AND, HOW LATE DID YOU PLAY CARDS?

16 A UNTIL AROUND 11:00.

17 Q ALL RIGHT.

18 HOW DO YOU REMEMBER THAT YOU PLAYED CARDS THAT FRIDAY?

19 A BECAUSE, IT WAS THE DAY AFTER THANKSGIVING.

20 Q ALL RIGHT.

21 IS THERE ANY OTHER REASON WHY YOU REMEMBER THAT DAY?

22 A YES. I WAS ARRESTED THE 11TH OF DECEMBER.

1 Q ALL RIGHT.

2 AND, YOU WERE ARRESTED ON THIS CHARGE, IS THAT RIGHT?

3 A YES, MA'AM.

4 Q WHERE WERE YOU ARRESTED?

5 A I WAS ARRESTED AT CITY HALL APPLYING FOR A CAR PERMIT.

6 Q ALEXANDER, WOULD YOU PLEASE SHOW YOUR TEETH TO THE
7 JURY. AND, YOUR HONOR, I ASK MR. CAMERON TO PLEASE COME DOWN IN
8 FRONT OF THE JURY BOX. I WOULD LIKE TO SHOW THE JURY SOME SCARS
9 ON HIS HAND.

10 THE COURT: ALL RIGHT.

11 BY MS. MOORE:

12 Q COME RIGHT DOWN HERE AND PLEASE SHOW THE JURY THE SCAR
13 ON YOUR HAND, AND HOW LONG HAVE YOU HAD THAT SCAR?

14 A APPROXIMATELY THREE YEARS.

15 MS. MOORE: I HAVE NO FURTHER QUESTIONS. YOUR HONOR,
16 I DO HAVE THREE LAB REPORTS MARKED DEFENDANT'S EXHIBITS "A," "B"
17 AND AND "C" TO MOVE INTO EVIDENCE.

18 THE COURT: CROSS EXAMINE, MR. KLOCH?

19 MR. KLOCH: THANK YOU, YOUR HONOR.

20 THE COURT: ANY OBJECTION?

21 MR. KLOCH: NO, I HAVE NO OBJECTION TO THE LAB REPORTS,
22 YOUR HONOR.

1 THE COURT: ALL RIGHT.

2 (WHEREUPON, THE DOCUMENTS REFERRED
3 TO WERE MARKED DEFENDANT'S EXHIBITS
4 "A," "B" AND "C" FOR IDENTIFICATION,
5 AND WERE RECEIVED IN EVIDENCE.)

6 CROSS EXAMINATION

7 BY MR. KLOCH:

8 Q MR. CAMERON, YOU SAID YOU RECALLED THE 28TH OR THE DAY
9 AFTER THANKSGIVING, IS THAT CORRECT?

10 A YES, SIR.

11 Q WHERE WERE YOU ON THANKSGIVING?

12 MR. CLARK: I WOULD OBJECT. I THINK THAT IS OUTSIDE
13 THE SCOPE. HE DIDN'T TESTIFY AS TO WHERE HE WAS ON THANKSGIVING
14 OR WHAT HE WAS DOING. IT WAS SIMPLY AS A POINT OF REFERENCE.

15 MR. KLOCH: YOUR HONOR, --

16 THE COURT: (INTERPOSING) OVERRULED.

17 BY MR. KLOCH:

18 Q WHERE WERE YOU ON THANKSGIVING?

19 A AT HOME, SIR.

20 Q ALL DAY ON THANKSGIVING?

21 A ALL DAY.

22 Q AND THE DAY BEFORE THAT?

A YES, SIR.

- 1 Q ALL DAY AT HOME?
- 2 A YES, SIR.
- 3 Q AND, YOU WERE AT YOUR MOTHER'S HOUSE ON THANKSGIVING?
- 4 A YES, SIR.
- 5 Q YOU HAD THANKSGIVING DINNER THERE?
- 6 A YES, SIR.
- 7 Q WITH YOUR MOTHER?
- 8 A YES, SIR.
- 9 Q ALL RIGHT.
- 10 AND, WITH MARVIN TOO?
- 11 A YES, SIR.
- 12 Q AND, WITH VICTOR, YOUR OTHER BROTHER?
- 13 A I DON'T RECALL VICTOR BEING THERE.
- 14 Q YOU DON'T RECALL WHETHER YOUR BROTHER WAS WITH YOU AT
- 15 THANKSGIVING?
- 16 A HE WAS NOT THERE, SIR.
- 17 Q AND, HOW ABOUT ON THE 28TH, WAS YOUR BROTHER VICTOR
- 18 THERE TOO?
- 19 A NO, SIR.
- 20 Q NOW, YOU MENTIONED THAT YOU WERE PLAYING CARDS ON THE
- 21 28TH WITH YOUR MOTHER, BOB MCQUEEN, DERRICK AND MARVIN?
- 22 A RIGHT, SIR.

1 Q NOW, YOUR MOTHER IS HERE IN COURT, IS SHE NOT?

2 A YES, SIR.

(WHY DIDN'T SHE TESTIFY AS TO HIS ALIBI?)

3 Q AND, HOW ABOUT BOB, IS HE HERE?

4 A NO, SIR.

5 Q HOW ABOUT DERRICK?

6 A NO, SIR.

7 Q OR MARVIN -- MARVIN IS YOUR HALF-BROTHER?

8 A RIGHT, SIR.

9 Q AND, YOU ARE POSITIVE YOU WERE HAVING THANKSGIVING
10 DINNER IN FAYETTEVILLE?

11 A YES, SIR.

12 Q AND, THAT IS WHAT, ABOUT SEVEN OR EIGHT HOURS FROM
13 HERE BY CAR?

14 A RIGHT, SIR.

15 Q PARDON?

16 A YES, SIR.

17 MR. KLOCH: NOTHING FURTHER, YOUR HONOR.

18 THE COURT: ANY REDIRECT?

19 MS. MOORE: NO, YOUR HONOR, EXCEPT TO MOVE THESE
20 THREE LAB REPORTS INTO EVIDENCE.

21 THE COURT: ALL RIGHT. THEY WILL BE ADMITTED.
