Q. Do you know of any problems between Darryl & Rose?

A. One time Rose told me Darryl came over real late - 1 AM or 2 AM - & she got mad at him.

Q. Do you know if Darryl used drugs?

A. No - But Sunday the day after the murder, Nicole Skeeters called me about Darryl getting arrested. She told me that Darryl had stolen her MAC card - and money - one time. She told me she thought he may have brought drugs.
