Q- When did you last TALK TO Roseann Young?

A- Two evenings prior to their death, it was a THURSDAY. I spoke to her on the phone.

Q- Did you know a person named Darryl, who was arrested for the murder of Roseann Young & Pamela Blue?

A- I didn't know him but I heard his voice over the phone. I was over Rose's house about a week or two before Valentine's Day.

Darryl called Rose on the phone & I listened to both Rose & Darryl talking on the phone. Rose wanted me to listen to the conversation, since we both were seeing each other & she felt uncomfortable with Darryl calling.

A - Yes - She told me he would come around 3 AM in the morning. He would bang on the door. He would beg Pam or Rose to open the door.

Q - Do you know if Darryl ever assaulted Rose or Pam?

A - No.

Q - What was your relationship with Rose around the time of her death?

A - She was not happy with me, since I was going away to school and she just did not want me to go. She invited me to be with her.
