Q. Delicia, did you know either of the two females that were found inside of 146 N. Millick St.

A. Yes, I am a very good friend of Pam and Rose. Rose is my babysitter. The house belongs to Rose, and Pam lives with her.

Q. How did you find out that the girls had been killed?

A. Yesterday morning I dropped off my two children so Rose could watch them while I was at work. I spoke to Rose, and she was planning to keep them until today. I spoke to her last night about 6:30 P.M. That was the last time that I spoke to her, and she sounded normal. Pam had not come home from work yet. I called this morning about 8:00 A.M. I got Rose's answering machine and left a message, and then I called Pam's line and left another message. I called back from work periodically, and about 10:30 A.M. I called Pam's job at JC Penney's to see if she knew where Rose was, and they told me that he was not due in until 10: PM. I waited until 1:30 P.M. and left another message.

cont..... I called Pam's job and she had not showed up yet. I started to get worried. I did not know how my children were or where they are. At about 2:00 P.M. I asked a friend of mine to call for me because I was at work. At 4:00 P.M. I left work around 5:30 P.M. and I went straight to Millick St. I banged on the door about five times, and no one answered. I got in my car, and went home to check my messages. My friend called me or left a message stating that he was not able to get a hold of anyone at the house. I called Pam's job, and they told me that she never showed up for work. I called the police but I didn't remember the exact address on Millick St. I called a friend of mine Jeff, he is the father of my children. I asked him to meet me at the house. I drove myself. I stopped by Keith's house. Keith is Pam's ex boyfriend, and her children's father and Rose's nephew. We went to the house. The police were there when I got there. I had called the police back from Keith's house and got the exact address. Keith smashed in the window, and we heard the kids. Keith went into the house. I went in and I ran upstairs to the second floor and I see a guy up there, and he told me that his name was Darryl. I went into Rose's bedroom which is the front bedroom, and my son was in there. He is one year old. We were asking the kids where Pam and Rose were and they didn't know. I another child on the floor in the back room sleeping. All the time Darryl

~~was sitting on the bed.~~ Darryl said he is Kia's friend. Kia is a friend of Rose. I told him that he had to get out, and the police grabbed him. I asked Darryl where Pam was, and he said that she went to work and I knew that he was lying. I went downstairs to the first floor.

cont..... and Keith turned on the light in the dining room. We saw a coat laying on the floor. Keith started to scream. Keith started to yell that he killed her and not let him go. I lifted up the coat, and I saw Rose and she was face up, and there was n blood. He face looked swollen. Her pants were down. She had no underwear on, she had a t-s shirt on. Her pants were pulled down. I started to scream. Imade all the kids sit in the back room upstairs. We asked the police to help find Pam. The police went to the basement and they went down and found Pam. I never saw Pam/ Rose was on the dininf room floor near the basement steps. Tbonwe all came down here.

Q. Did you have an opportunity to speak to your children about Darryl and what may have happened?

A. Pam's son Keith told me that Darryl got there about 1:00 A.M. and Rose let him in. Rose was upset because he had got there so late. They told me that Pam came down and started to holler at Darryl also. I asked when the last time that they saw her mother, and Keith it was this morning and she was in her bed sleeping in the backroom. I asked Keith if Darryl had done anything to him, and he said that Darryl had locked them in Rose's room the front room, and then he came back upstairs, and told them that Pam had gone to work. Keith told me that he (Darryl) went into the basement at one point. and when Keith went to the basement door. Darryl told him to go upstairs.

Q. How old is Pam?

A. She is 35 years old, and her mother and father in S,W Phila., and Rose is 23 or 24, and her family which is adpoted is Keith Smallwood, and his Rose's sister Angie. They live at 6150 W. Columbia Ave.
