A - *4 & 12:AM, assigned to RPC 1917.*

Q - *Did you respond to the above incident?*

A - *YES, responded to a radio call of a disturbance at 146 Millick St. Upon arrival RPC 1918 was on location that would be P/O Prosser. P/O Prosser was talking to a B/M who identified himself as the owner of the house, he was with a B/F she was inside. P/O Prosser told me she went through a window because the door was locked.*

I looked through the window and told the suspect to come out through the window. As the male was about to be run through the computer, we heard the female in the house say, "There a dead body in here." I left the suspect with P/O Prosser and went through the window and found in the living room one B/F with a blue cloth stuffed in her mouth, she was naked and appeared to be dead. The owner - Keith was saying "WHERE is the other female, I checked the basement and found another B/F at the bottom of the steps. With her hands tied behind her back with some type of material and a piece of material around
