REBECCA SCHELL , being first duly sworn, deposes and says:

That she is a police officer with the Clark County School Police, being so employed for a period of 3 years, assigned to investigate the crime of SEXUAL ASSAULT committed on or about 1/18/93 which investigation has developed CURTIS LUNDY DOWNING as the perpetrator thereof.

That affiant developed the following facts in the course of the investigation of said crime to wit:

1. THAT ON 1/18/93 TAMI ZOLD REPORTED TO POLICE THAT SE HAD BEEN SEXUALLY ASSAULTED AND MADE SUBSEQUENT STATEMENTS TO POLICE REGARDING THAT SEXUAL ASSAULT.
2. THAT ZOLD STATED THAT SHE BECAME THE VICTIM OF A SEXUAL ASSAULT WHEN A MALE, WHOM SHE DID NOT KNOW, BY MEANS OF FORCE AND INTIMIDATION PERPETRATED AN ACT OF CUNNILINGUS UPON HER AGAINST HER WILL.
3. THAT ZOLD STATED SHE BECAME THE VICTIM OF A SEXUAL ASSAULT WHEN A MALE , WHOM SHE DID NOT KNOW, BY MEANS OF FORCE AND INTIMIDATION PERPETRATED AN ACT OF SEXUAL ASSAULT ON HER WHEN THE SUSPECT PLACED HIS PENIS IN THE VICTIM'S VAGINA AGAINST HER WILL.
4. THAT ZOLD STATED SH BECAME THE VICTIM OF A SEXUAL ASSAULT WHEN THE SUSPECT PLACED HIS FINGERS IN HER VAGINA AGAINST HER WILL IN A EFFORT TO REMOVE SEMEN HE HAD DEPOSITED.
5. THAT THE SUSPECT IN THE ABOVE CRIME MATCHED THE DESCRIPTION OF CURTIS DOWNING.
6. THAT THE M.O. CLOSELY MATCHED THAT OF A CASE FOR WITCH DOWNING WAS IN CUSTODY (930121-0372). DOWNINGS PALM PRINT HAD BEEN FOUND ON THE SCENE OF THAT CRIME. *Girl Friend residence.*
7. THAT A SEROLOGY TEST HAD BEEN TAKEN FROM DOWNING UPON ARREST FOR THE CRIME MENTIONED IN #6.
8. THAT A SEXUAL ASSAULT KIT HAD BEEN TAKEN FROM ZOLD ON THE NIGHT OF OCCURRENCE.
9. THAT A DNA COMPARISON OF DOWNING AND THE SAMPLE RECOVERED FROM THE VICTIM, ZOLD, SHOW THE DONOR TO BE CURTIS DOWNING.
