DETAILS: The following is the transcription of a tape-recorded interview conducted by DETECTIVE J. FOX, P#469, LVMPD Sexual Assault Detail, on 01/25/93 at 1100 hours. Persons present are DETECTIVE FOX and KRISTIE CHILES.

Q. Kristie, we have spoken of the sexual assault which you were a victim of back on January 21st of this year. Would you tell me where you were about 5:40 in the morning?

A. I was in my bed.

Q. Okay.

A. I was sleeping KC

Q. Did something awaken you?

A. yes, he jumped on top of me. KC

Q. Okay. What did he do?

A. He rolled me over --

Q. Onto your back?

- A. Onto my back. Do you want to ^{KC} know what I was wearing?
- Q. Pardon me?
- A. Wanna know what I was wearing?
- Q. Yes.
- Q. A black and white SILK ^{KC} nightshirt. I had nothing on underneath. He then taped my eyes. I asked him not to tape my mouth, and he didn't. I asked him not to tie my hands behind my back so he tied 'em in the front of me with a white rope. Then I asked him, I figured he was gonna rape me anyway, so I asked him to not rape me in my bedroom and to take me to the living room. When we got to the living room, he asked me to... He asked me where my wallet was and I, I told him in my ^{KC} black bag He got my wallet and he couldn't find the money. And so, he handed me the wallet and he said, get the money. And I got it. It was like 42 to 45 dollars, I can't remember. And, at that point, he laid me down --
- Q. On your stomach or on your back?
- A. On my back.
- Q. On the floor?
- A. Uh huh. And he performed oral sex.
- Q. Okay. Be specific.
- A. And we--, went and kissed me on my neck, all the way down. Do I have to say where? ^{KC}
- Q. Uh huh.

A. My breasts and my vagina. And I asked him to wear a condom.
That's what I think he did.

Q. Okay. Why did you aske him to wear a condom?

A. 'Cause I had told him that I had a disease. But I was the one
who was afraid of getting one, you know?

Q. Okay.

A. Then, then he raped me.

Q. Okay. Were you still on your back?

A. I was still on my back.

Q. When you say he raped you, what did he do?

A. He had intercourse with me.

Q. Okay. Did he put something inside of you?

A. Uh huh.

Q. What?

A. His penis.

Q. And where did he put it?

A. Vagina.

Q. Okay. Do you know if he ejaculated?

A. I don't know.

Q. Go ahead.

A. And after that, the phone rang and that's when I knew what
time it was because my boyfriend said on the machine it was
ten after six.

Q. Okay. You're talking about an answering machine?

A. An answering machine.

Q. All right. What did he do when the phone rang?

A. He got up. He waited for the message to go all the way through. And then he fumbled around and finally got the tape out. And he, guess he took the tape with him. And --

Q. Where, where were you during that time?

A. I was standing next to him, I believe. 'Cause I could feel this, I could feel his body

Q. Did he move you. In other words, he moved you from the floor.

A. Yeah. I jus--, I got up. I just stood up.

Q. Okay.

A. And I could feel him, his like sweatshirtish (phonetic) clothes next to me. And I grabbed hold of him. I was afraid of the dark and to hold my hands to reassure me that the gun wasn't in his hands.

Q. When he did that, where did he hold you?

A. He just held my hand.

Q. Was he wearing --

A. Gloves with a knit top and leather bottom.

Q. Okay.

A. _____ And, then after that, he laid me down and told me that _____ liked doggy style, kinda and --

Q. Okay. When you say doggy style, what are you referring to?

A. I was on my knees and my hands.

Q. Okay.

A. And then, then he raped me again. And he held me like by my sides, ^{ye} by my waist. And the gloves were off then at that point.

Q. Did he again put something inside of you?

A. Yeah. He put his penis in my vagina.

Q. Okay. Did he ejaculate that time?

A. I, I do not know.

Q. Okay.

A. And, I lifted the tape off my eyes a little bit so I could see if I could see him, but all I could see was a silhouette 'cause it was dark. But the flashlight was on that he had and I could kinda see him _____. And then the minute I turned my head, he told me to turn it back to, you know, straight. And I heard a noise at the door. I asked him who it was and he said it was his partner or something like that. And then, during, while he was raping me, he kinda laughed, like a deep laugh. And I asked him if his partner was going to rape me, and ^{that's} ~~when~~ he said? "No he doesn't want none of you. And he got off. _____ stopped anyway and told me to go in the bathroom, shut the door and lock it and run water. And I ran into the wall and he helped me into the bathroom. He took the tape off of my eyes and I turned the light on in

the bathroom and that's the first time that I seen him with a ski mask on.

Q. Lemme stop you just a moment. When he first wakened you -

A. Uh huh.

Q. Was he wearing the ski mask? *KL*

A. Yes he was.

Q. Okay. At the time that you were on your hands and knees and he was having intercourse with you --

A. Uh huh.

Q. -- and you were able to raise the tape and look back, was he wearing the ski mask then?

A. No he wasn't.

Q. Okay. Okay. Anyway, you're... Let's get back to when you're in the bathroom.

A. I'm in the bathroom and ~~he~~ ^{*IKL*} turned the light on and he said, (pause)... Oh, he said, "Run the water". Shut the door and then ~~for~~ ^{*Lie KL*} I forgot to run the water 'cause I was scared and he said, "Open the door or I'll kick it down". So I ^{*the floor.*} opened the door and he was making comments throughout the whole time and then --

Q. What kind of comments?

A. Like, you shouldn't talk ~~to me~~ ^{*KL*} about Latinos. This is what you get. You brought this on yourself. Just things like that.

Q. Had you been talking about Latinos?

A. No. We hadn't even mentioned that. It was the first time that he caught me off-guard, you know. I didn't, (crying) I didn't even mention it ^{during the whole thing} He told me to get in the shower. I got in the shower. He watched me take a shower. He kept telling me to wash myself.

Q. Was he specific as to what part of your body to wash?

A. No but if I didn't wash that, he could see me wash myself. And when I did wash my vagina area, that's when he wouldn't say anything to me. I turned the water off. I looked out in the, out the bathroom door and he was looking out the blinds.

Q. Blinds where?

A. In the front bedroom facing west and he came and then he told me to get... They talked about Latinos again and I, I told him that he looked black to me. And that's when he made the comment about his parents. His mother being Latino and his father being black and that's why I would think that. He lifted up his sweatshirt saying, di--, showing me that his coloring. ^{NOS not that dark} He showed me his coloring and I noticed... I, that the hair on his arms were kinda hairy. I realized his eye. It was real, it was droopy, kinda like smaller than his other one.

Q. Was that the first time you noticed his eye?

A. No. The first time I noticed his eyes before I even got in

the shower. From the minute he took the patches off my eyes, I could see him. I noticed his eye right off.

Q. Okay. Which eye was drooping?

A. It was my left, so it was his right. And he kept makin' comments after I got out of the shower-- I brought this on myself and, uhm, he said that I knew him, but I didn't give him the time of day. Uhm, I kept tellin' him I didn't recognize him and he said that I knew him. I had seen him. And, uhm, he was gettin' irate and I just said, "Could I shut the door?" And I shut the door. And, uhm, I heard the blinds rattle. Then I heard the door shut after that and I thought he was gone.

Q. Okay. Would you describe this man to me?

A. Yeah, he's about 6'3", 250 lbs.

Q. What type of build?

A. Like a football build. He's, uhm, he's not muscle bound or anything. He's just big. He's just big-- kind of, uh, flabby big.

Q. Okay. Now I understand he was armed with a gun. Would you describe that?

A. Yes. It's black to dark brown. It's a revolver 'cause I remember the little-- the round--

Q. Cylinder?

A. Uh-huh.

(What?)

Q. About how a barrel?

A. Maybe four inches.

Q. Which hand did he hold it in?

A. His right.

Q. Okay. When did he first display it?

A. When he jumped on me in the room. It was pointed at ^{the} back of
the head.

Q. Now as I remember, you were telling me when you were in the bathroom and turned the lights on and he was standing in the doorway, that you could see the gun?

A. Uhm-hum. It was under his--

Q. And the tape?

A. Uhm-hum.

Q. And the flashlight. How was he holding those?

A. The flashlight was in his right hand. The tape was in his left. And the gun was under his left armpit.

Q. What type of flashlight?

A. A real little one. It's blue and it has a string on the back of it.

Q. Okay. A bright blue or a dark blue?

A. A dark blue.

Q. What color was the tape?

A. White.

Q. Okay. And how 'bout the rope?

- A. It was white too. It's plastic.
- Q. Okay. It was stiff or soft?
- A. It was stiff.
- Q. How was he dressed?
- A. Uhm, he had on, uhm, his pants were, uhm, dark blue. Just dark. Dark blue pants.
- Q. Were they sweat pants?
- A. Yeah. Dark grayish color sweat shirt. Could be the other way around. I think I remember-- I remember a white T-shirt collar hangin' out.
- Q. Okay. Was the sweat shirt a pullover or a zip up?
- A. It was a pullover. There was nothin' on it.
- Q. Did you notice any pockets?
- A. I didn't notice any pockets.
- Q. How 'bout shoes?
- A. His shoes I didn't even notice.
- Q. When he sexually assaulted you, did he remove his clothing?
- A. His pants.
- Q. Did he speak with a Latin accent?
- A. It was a real bad one. It was kind of-- his voice, you could tell, was altered or somethin'-- the way he was talking. And the accent seemed like it-- as if I tried to speak Latino, I guess. It wasn't-- it wasn't a real good accent.
- Q. But it was your impression that he might be affecting the

accent?

A. Yeah.

Q. But at the same time, it could have been legitimate.

A. It could have been legitimate.

Q. What was his general demeanor? Was he rough and gruff?

A. No, he was just-- he was polite. I mean he was sympathetic. He-- but at certain times he would get irate with some of the things I said. If I mentioned that he looked black to me, he'd get irate about that. And then-- he was never really rough or brutal in the sense of physically harming me other than just the threatening and the gun and stuff.

Q. Did he threaten to do anything if you reported this matter?

A. Yeah. He said that he would kill me.

Q. When did he tell you that?

A. All throughout the rape and if I spoke, he would tell me to be quiet or he'd kill me or, uhm-- at one point he said to me, uhm, I said, "Please don't shoot me." And that's when he said to me, "Don't worry. I'll strangle you like I did all the others." That's one comment that he made that I-- (pause) I'm sorry.

Q. Is there anything you'd like to add to this, Kristie?

A. Uhm--

Q. Is there anything I've forgotten to ask you?
