I ran to check on her and that is when my aunt, Diana McNeal, screamed, "You all get in the car and go home." Dorian was inside my car already. I got in my car and started pulling off. That is when Marcus Jones threw a log at the back windshield of my car. The police officer (Officer Jackson) pulled my car over and pulled a gun on us. He told us to get out of the car and get behind the car. We were on our knees with our hands behind our heads.

Officer Jackson told us to hurry and get into the police car because the Bernice kids were coming towards us. After he said that I jumped in the front seat of the police car. When I sat in the front seat I felt something stick me on my leg. It was the knife that Officer Jackson had taken from the glove compartment of my car.

Earlier that week at a softball game in Spearsville, Lagario Thompson told me and Dakerry McNeal to bring Dorian to the party. He wanted me to bring Dorian so they could get him. I told him no because that would look like I was setting him up to get beat up.
