Investigation: Homicide.  
Subject: Interview of [REDACTED]

1- On 08-18-99 at approx 1915 hrs the u-s did speak to Mr. [REDACTED] in regards to this case and he stated the following:  
"Mr. [REDACTED] stated that he returned from work at approx 3:30 p.m. He had dinner and he went to take his delivery truck back in the company of his wife [REDACTED] and his two daughters [REDACTED] and [REDACTED]. He went to pay his tel bill and then went to Strauss to pick up some items to repair his car. He then returned the truck and arrived back at his residence at approx 5:00 p.m. After he arrived at his residence the phone rang and [REDACTED] picked up the phone. It was [REDACTED] and he asked my wife if she had seen Johanna. SHE stated that she hasn't seen her. Then [REDACTED] went downstairs to change the oil to his vehicle. While downstairs Manny was outside and we were talking back and forth and he was on his cell phone calling people trying to locate his wife. He was also asking about his dog. He has a Boxer named ROCKY. The dog was missing and Manny had asked the super across the street. He used some of his tools and was in and out of the apt, the kitchen area and by the front door where Manny had some tools that he was using. The last time I saw Johanna was Monday when she had dinner with Manny and [REDACTED] at his residence. After he finished working on his car he went inside and got some soap and washed his hands in the hydrant. He went back outside to get a towel to dry his hands and Manny started to yell his name. He went to the room and the room was not a mess. Manny lifted the black bed and he saw Johanna on the floor. He left out the room and didn't go back in. Manny was grabbing her. He then left the apt. and went outside. His brother-in-law George Rodriguez called 911."
