- On 08-19-99 at approx 0330 hrs Mr Kleber Vega was present at the 46th pct and he stated the following:  
  
"Stated that he is staying wit his father [REDACTED], at above address for approx 3 weeks. He moved out of his brother's house because of a joke he played on brother of his sister-in-law. He cut his hair with a machine and they didn't like it. On 08-17-99 he arrived at his father's house about 13"30- 12:00 midnight from work in Patterson N.J. where he works. He went upstairs and didn't come back down until 7:30 a.m. when he went to his cousin's house located at the next project over from his father's house. The aunt [REDACTED] takes him to Patterson where he is dropped off at another aunt's house, Aurora Figueroa, and waits there to be picked up by cousin in delivery van. He returns to NY by bus after completion of drops. Last time he went to Manny's house was on sunday at approx 10:00 p.m. Hasn't spoke to them since Sunday.
- At approx 0430 hrs the u-s along with Det. Catalano visited [REDACTED] and spoke to [REDACTED] who is his step-mother and she stated that Kleber arrived at her residence at approx 11:30 p.m and did not leave apt until approx 07:30 a.m. the next day.
- Case open for further investigation.
