1. On 8/18/99 at approx. 1915hrs the undersigned did interview Mr Oscar Vivar J. DOB: 11/29/64 who resides at 265 Edwards Pl Yonkers, NY beeper# (917) 460-8749 work# (914) 423-7777 Mr. Vivar works for Mile Square bus Co. at 41 Torre Pl Yonkers, NY. This interview was conducted inside apt#CC at 231 Echo Pl. and Mr Vivar stated the following: Yesterday at about 12:30 - 12:45PM I picked up Johanna at the Amaco gas station on Yonkers Ave to take her to her road test, at 1:00PM I drove her to New Rochelle behind the Hospital in her red toyota celica after I left my bus in the gas station. She took the road test and failed, I drove her back to the gas station in Yonkers then I left with my bus and Johanna took the car back to the Bronx. Today at about 5:18PM (time & number on his beeper) Manuel beeped me to (917) 734-1629 his cell phone. I called back about 10-15mins later to the cell phone number, he asked me if Johanna called me and I told him no. I asked him why? and he ~~was~~ said he "I can't find Johanna or my dog". I told him I would come to his house in one hour.

2. Mr. Vivar further stated that he knows Johanna for about 4yrs since He came here from Equador when Manuel introduced them in the house where they used to live. ? Manuel works for Tony's fish market in Hunts Point. Manuel has a daughter named "Betty" F/11-12 from another relationship.
