1- On 08-18-99 the u-s dixx speak to Ms Fanny Valencia in regards to this investigation and she stated the following:
 Fanny states that she last saw Johanna and Manny on Mon 08-16-99 at approx 1700 hrs. They had supper and left. This morning at about 7:50 a.m. I received a call from Manny asking to see if I heard from Johanna and I stated no. He said that he has been trying to call her but he has gotten no response. Johanny and I were to go out this morning to go and fill out an application to work. We were to meet at approx 0645 hrs. I woke at about 0640 and I called her to see if we were still going and I got no response, so I kept on sleeping until her husband called me at 7:50 a.m. Manny called me again approx 10:00 in the morning and he called me from downstairs because I asked him if he wanted me to check downstairs but he said that he was already downstairs and she wasn't there. I then didn't here from him until this afternoon when I returned with my husband and my two daughters when he told me that his dog was missing and that her keys, her bag with her money was still in the apt. He was searching the apt to see if she had changed her clothing and I went to the bathroom to see if any of her clothing was in the bathroom. The door to the bathoom was closed but not locked. I was in the hallway with my two daughters when he yelled out for my husband. He was in the room and already had moved the bed against the wall. I then left with my daughter and my husband came in. I don't know if they were arguing but the day that they were here they didn't seem like they were. Manny had left the keys to the apt with my daughter at approx 1230 before he went back to work in case Johanna returned befor he did.
