On 8/19/99 at approx. 003 0hrs the undersigned did interview Mr. [REDACTED] DOB: [REDACTED] who resides at [REDACTED] with his [REDACTED] and is temporarily staying with a [REDACTED] at [REDACTED] until he moves into his new apt [REDACTED]. Mr. [REDACTED] made the following statement regarding this investigation: Yesterday at about 5:00PM I went to Manuel's house to get some clothes, when I got there Manuel was there with his wife, Manuel was laying on his bed in the bedroom and the T.V. was on. Johanna was in the kitchen cooking I went to my old room got some clothes, went to the bathroom washed up. Johanna asked me if I wanted something to eat while I was in the bathroom, I told her Ok!. When I came out of the bathroom Manuel was sitting at the kitchen table eating. I had fish to eat. We were all talking, Manuel was talking about moving to Pennsylvania because he wanted to buy a house. I went back into my old bedroom got my clothes when I came back out Manuel gave me the keys to the van (astro van) and told me to have it back by 12:30AM. I left the apt drove to my mothers block (150st & B Way) I stayed with my daughter "Evelyss" in my mothers house for a while. I drove back to Manuel's house at about 9:00PM or 9:30PM went inside and the door to their bedroom was closed and the dog was chained to the hook by their bedroom. When I went back to the apt I was hoping to see manuels brother "Kleber" who's room my belongings are in. Kleber wasn't there so I grabbed some of my clothes and went back over to Weeks Ave dropped the clothes off and then went back to my mothers house on 150st. I then left my mothers house and brought the van back to Manuels house parked the van by the hydrant, let myself into the apt with my key (about 11:45PM)

the dog was still chained outside their bedroom and their door was still closed, I went into the kitchen hung the keys up to the van and then left the apt, locked the door and took a cab to my girlfriends house [redacted] and stayed there all night. Today while I was at my mothers house she received a phone call from my cousin [redacted] who asked my mother if we had seen Klebar when we said no, she told us that they found Johanna dead in Klebars bedroom.

2. On 8/19/99 the undersigned along with Det Infante did respond to [redacted] and did speak with [redacted] [redacted] tel# [redacted] Ms Taveras did state that last night at about 11:00PM or 12:00 midnight [redacted] came to her apt let himself in with his key came to her bedroom, they talked for a while she fell asleep and [redacted] stayed up watching T.V. They both left in the morning to go to work. They have been together for 10yrs on and off.
3. In view of the above facts the undersigned requests this case remain active.
