**SUMMARY:**

Upon arrival the undersigned was informed that above stated victim was found lying on her left side under a couch in a bedroom of stated location. No apparant wounds on Victim, cause of death to be determined by an autopsy. The location was photographed, sketched, and four (4) pieces of evidence was recovered.

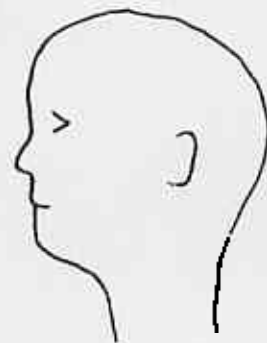

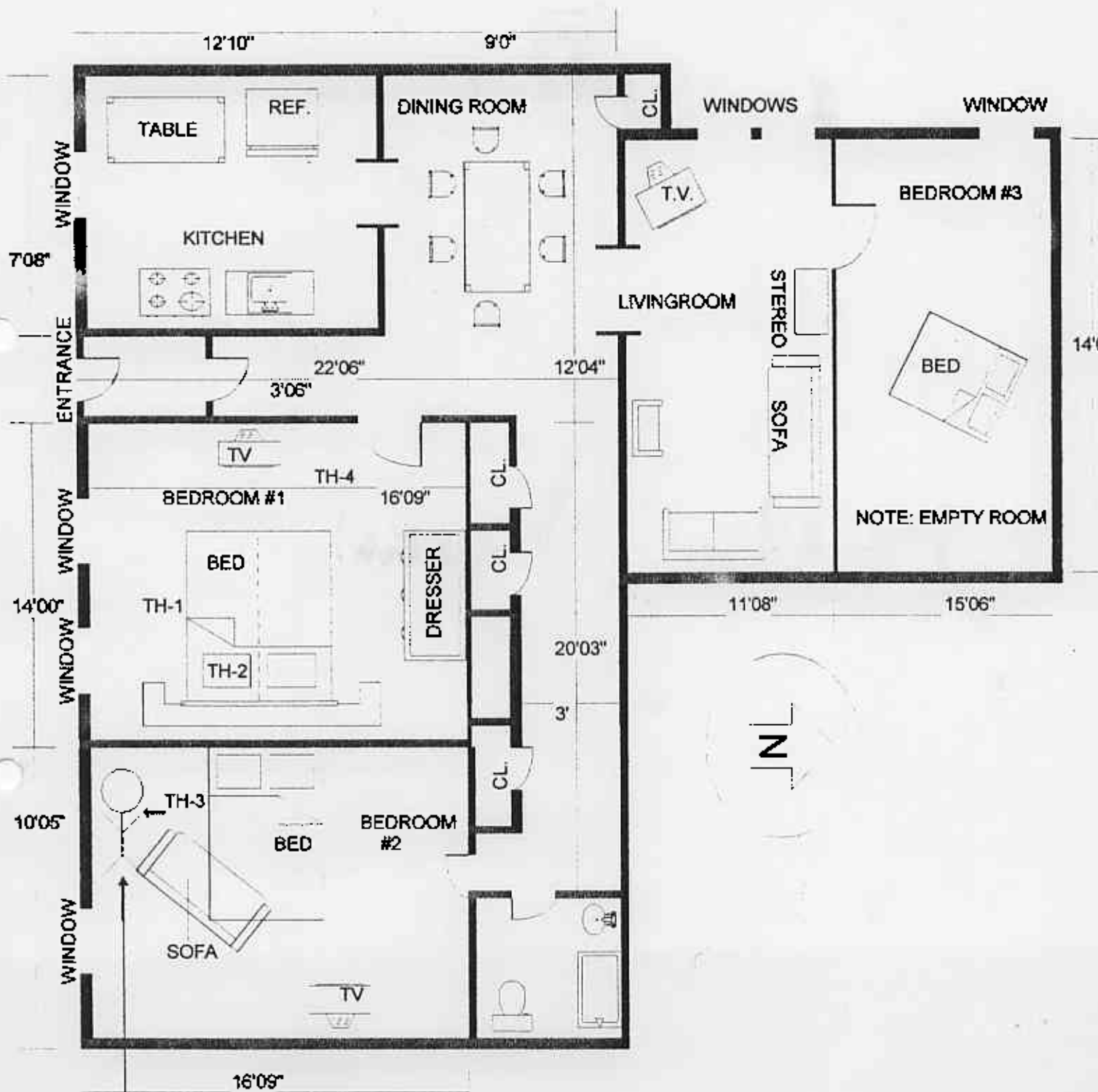
