On 4/21/98 at approximately 13:00 hours, a Mr. Fidel Morel of 233 E. Phila. Street first floor, came in to speak with Detective Williams and I. Mr. Morel was upset that there were rumors in the street that he was involved in the homicide of Manuel and Miriam. Mr. Morel was asked to tell us what he remembers from that evening. Mr. Morel states that he was watching television that evening, when he heard someone knocking at the apartment of Miriam Asencio on the second floor. He then heard a voice of a man asking to be let in. Mr. Morel recognized the voice as that of Milton Matos Montalvo. He hear Milton Matos Montalvo demanding that the door be opened. He heard Milton Matos state "I saw, a man go in here. Open the door now." Mr. Morel then heard glass break near the door entrance to Mrs. Asencio's apartment. Shortly thereafter, Mr. Morel heard Miriam Asencio and Milton Matos Montalvo arguing very loud. He then heard loud banging and loud thumps on the floor of her apartment. Mr. Morel heard Miriam Asencio yelling "Somebody call the police." Mr. Morel states that this kind of domestic between Miriam and Milton was an every weekend occurrence. So he did not call police and shortly after she was yelling for the police, it became quiet in her apartment and Mr. Morel believed that they were done fighting for the night. He said he went to bed. Mr. Morel said that he believes that the arguing and loud noises he heard occurred at about 02:30 to about 03:00 hours that morning. He states he was watching television and when the arguing started, he looked up at the clock on top of the television and saw it said about 02:30 hours. He remembers the time, because he looked at the clock and wanted to go tell them to stop making so much noise, but he decided not to go up to her apartment.
