COUNT I

JERRY M. BLAIR, State Attorney of the Third Judicial Circuit of Florida, charges that HENRY CLAYTON BURKETT from on or about January 1, 1992 until on or about May 13, 1993 and on divers dates between said dates, in Suwannee County, Florida, standing in a position of familial or custodial authority over K.B. (FEMALE, 16 YEARS OF AGE), a child 12 years of age or older but less than 18, did then and there unlawfully engage in sexual activity with said child by placing his penis into or in union with the vagina of said child, contrary to Florida Statute 794.041.

COUNT II

JERRY M. BLAIR, State Attorney of the Third Judicial Circuit of Florida, further charges that HENRY CLAYTON BURKETT from on or about January 1, 1992 until on or about May 13, 1993, and on divers dates between said dates, but subsequent to the incident(s) referred to in County I, in Suwannee County, Florida, standing in a position of familial or custodial authority over K.B., a child 12 years of age or older but less than 18, did then and there unlawfully engage in sexual activity with said child by placing his penis into or in union with the vagina of said child, contrary to Florida Statute 794.041.

JERRY M. BLAIR, State Attorney of the Third Judicial Circuit of Florida, further charges that HENRY CLAYTON DURKETT on the 14th day of May, 1993, in Suwannee County, Florida, standing in a position of familial or custodial authority over K.B., a child 12 years of age or older but less than 18, did then and there unlawfully attempt to engage in sexual activity with said child by attempting to place his penis into or in union with the vagina of said child, contrary to Florida Statute 794.041.
