
Note: Exhibits listed in this report were received in sealed containers with the seals intact. No signs of tampering with the sealed containers were apparent.

FINDINGS:

(Fingerprint Division Report):

1. Examination of Exhibits 1, 10 through 16, 19, 21, 23, 24, 26 through 28, 46, 47, and 57 revealed latent prints on Exhibits 27-2, 27-3 and 47, which are suitable for identification.
2. Comparison of the above listed latent prints with the record prints of Exhibits 48 through 56 revealed that one of the latent palmprints of Exhibit 47 was made by the individual whose record prints appear on Exhibit 56 (HANSON). The remaining latent prints were not identified.
3. Photographic copies of the unidentified latent prints are retained in the files of this laboratory for comparison with any additional record major case prints that may be submitted.

(Chemistry Division Report - Serology):

1. Serotyping of the below listed exhibits gave the following results:

2. Immunological examination of Exhibits 6, 7, 9 and 20 revealed the presence of human blood. Typing examinations gave the following:

FINDINGS: (Continued)

3. Electrophoretic PGM sub type of Exhibit 6 indicated Type 2+1⁻.
4. Comparative microscopic examination revealed that:
 - a. Exhibit 34-2 contained no foreign hairs.
 - b. Head hairs removed from Exhibit 6 and those of Exhibit 31 (std. of Victim) were similar.
 - c. Exhibit 34-4 (std. of SPINDLE) and head hairs removed from Exhibit 3 (T-shirt), 18-2 (trousers of Victim), 35 (clothing in laundry bag) and 41 (clothing in laundry bag) possessed some similarities and a common origin can not be eliminated.
 - d. Exhibit 42 (std. of HUBBARD) and pubic hairs recovered from Exhibit 35 possessed some similarities and could not be eliminated as having a common source of origin.
 - e. A single Caucasian pubic hair taken from Exhibit 37 (T-shirt) was dissimilar to all other standards.
5. The following exhibits did not reveal the presence of any bloodstains: 1 through 5, 8, 10 through 16, 18, 19, 21 through 25, 28 and 35(1-3) through 41(1-3).
6. The following exhibits did not reveal the presence of any seminal stains: 3, 5, 6, 7, 10, 18, 20, 22, 25, 28, 35(1-3) through 41(1-2).

(Chemistry Division Report - Drug):

Examination revealed the presence of tetrahydrocannabinol (THC) in Exhibit 23.

Note: Tetrahydrocannabinol is listed in Schedule I of Public Law 91-513.

(Chemistry Division Report - Trace):

1. Mineralogical examinations of Exhibits 1, 2, 3, 4, 5, 6, 10, 18, 20, 22 and 29 found them consistent in their make up.
2. Microscopic examinations of Exhibits 2, 3, 4, 5, 6, 10, 11, 12, 13, 14, 18, 20 and 22 disclosed the presence of similar excipient material.
3. Microscopic examination of the following exhibits disclosed the presence of:
 - 8-1 (L) thumb-cotton fibers, paper fibers and various minerals.
 - 8-2 (L) index-vegetable, cotton and paper fibers, various minerals.
 - 8-3 (L) middle-acrylic, vegetable, cotton and paper fibers, various minerals.
 - 8-4 (L) ring-vegetable, cotton and paper fibers, various minerals.
 - 8-5 (L) little-vegetable and paper fibers, various minerals.
 - 8-6 (R) thumb-vegetable, cotton and paper fibers, various minerals.
 - 8-7 (R) index-vegetable, cotton and paper fibers, various minerals.
 - 8-8 (R) middle-vegetable, cotton and paper fibers, epidermal tissue various minerals.
 - 8-9 (R) ring-vegetable, cotton and paper fibers, epidermal-tissue various minerals.
 - 8-10 (R) little-vegetable, cotton and paper fibers, various minerals.
