## STATEMENT:

MASON STATED THAT HE PULLED INTO HIS DRIVEWAY WITH HIS FRIEND  
 FOLLOWING BEHIND HIM, ANTHONY THOMAS, MASON STATED THAT AS HE APPROACHED  
 THE EAST (REAR) DOOR HE NOTICED A B/M STANDING BY THE DOOR. MASON  
 STATED THAT HE HEARD SOMEONE INSIDE THE HOUSE TOO. MASON ALSO SAW  
 PETER RABBIT STANDING IN THE BACK YARD W/O A HOOD (FACE MASK). MASON  
 STATED THAT THE SUSPECTS STARTED SHOOTING AT ANTHONY THOMAS & HIMSELF.  
 MASON LEFT IN HIS VEHICLE UNSCATHED BY THE BULLETS BEING FIRED AT  
 HIM. MASON APPROACHED R/O AT GILMORE & RUSSELL & INFORMED R/O OF WHAT JUST  
 HAPPENED. R/O & OFC FONG WENT TO THE SCENE & CHECKED THE HOUSE.

## CONTINUED:

MASON STATED THAT THE ONLY THING MISSING WAS A GOLD RING & MATCHING GOLD WATCH.

## POINT OF ENTRY:

- ATTEMPTED TO PRY EAST (REAL) SECURITY DOOR OPEN. THEY FINALLY GAINED ENTRY THROUGH THE EAST WINDOW NEXT TO THE DOOR. SUSPECTS HAD TO PRY THE BARS OFF THE WINDOWS.

## METHOD OF ENTRY:

FORCED OFF THE SECURITY BARS OVER THE WINDOW THEN SMASHED THE WINDOW.

CONTINUED:

THOMAS STATED THAT AS THEY WALKED TO THE EAST DOOR HE SAW A B/M WEARING A MASK. THOMAS STATED THAT THE B/M STARTED SHOOTING AT MASON & HIM. THOMAS DID NOT RECOGNIZE ANY OF THE SUSPECTS. THOMAS FLED ON FOOT TO PARKSIDE. THOMAS WAS NOT INJURED.

R/O INVESTIGATION:

R/O & OFC FONG CLEARED THE RESIDENCE AT 3250 BUNDY. R/O NOTICED THAT THE EAST (REAR) DOOR WAS PRIED AROUND THE DEAD BOLT. THE GLASS WAS BROKEN ON THE DOOR, NO ENTRY WAS GAINED THROUGH THE DOOR. THE SECURITY BARS ON THE EAST WINDOW, NEXT TO THE REAR DOOR, WERE PRIED OFF. THE EAST WINDOW WAS BROKEN & ENTRY WAS GAINED. INSIDE THE RESIDENCE THE HOUSE WAS TORN APART. THE SUSPECTS WENT THROUGH ALL THE KITCHEN CUPBOARDS, THE REFRIGERATOR, FLIPCOVER THE BED, FLIPCOVER THE COACH CUSHIONS, & WENT THROUGH THE DROP CEILING TILES. THE SUSPECTS ALSO BROKE OUT THE NORTH <sup>WEST</sup> WINDOW. R/O FOUND FOUR BULLET HOLES IN THE '76 WINNEBAGO MOTOR HOME PARKED BEHIND 3250 BUNDY. R/O LOCATED THREE BULLET HOLES IN THE NORTH OUTSIDE WALL. R/O ALSO NOTICED THAT 92 CADILLAC 4DR SEVILLE PARKED IN THE DRIVEWAY HAD A SMASHED WINDSHIELD, TWO BULLET HOLES IN THE REAR TRUNK & BUMPER, AND BOTH DRIVER'S SIDE WINDOW WERE SMASHED OUT. OFC FONG LOCATED 3-380 CASINGS NEAR THE NORTHEAST CORNER OF THE HOUSE. THE SUSPECTS ALSO TOOK OUT THE FLOODLIGHT ON THE EAST SIDE OF THE HOUSE. R/O TAGGED ALL EVIDENCE & 612 FEDERAL.
