Keith went to the trunk of the car and put him in the trunk. He told me and my twin sister Karen (I ~~we~~ reached for a gun) he had a take of our clothes. My sister Karen taught so he put her in the trunk with Keith and told me to take

The (Black Man) ~~was~~ short, husky and a (dark Black color). He had on a diamond ring and a cross on his neck. His face was in between soft and hard and his hair was cut close to his head. He had beige pants and a different colored slit shirt. He had on a black saddle hat.
