

HELLO!

MY NAME IS WILLIAM D.IRVAN and I'm a TEXAS DEATH ROW INMATE.

I was charged in 2001 for a crime that happened in 1987, which resulted in the death of Michelle Shadbolt. I was having a relationship with this woman, who was going through a divorce. She and her husband had been split up for about 6 weeks and she had him committed to an Alcohol Rehab. 2 times. She told him 2 days before she was found dead, that they were finished and that she was filing for a divorce.

They knew that he killed her, all through the D/A's file they say that they know he did it. They told him so. I had sex with her the day before she was killed. They took swabs from her and found my semen. In 2000 they tested the swabs and 2 hairs. She had 4 pubic hairs under her nails but they only tested one of the hairs and it did NOT MATCH ME OR HER. One bloody hair from the vacuum cleaner that was found on top of her was NO MATCH TO ME OR HER. **THE HUSBAND WAS NOT TESTED TO THESE ITEMS???** The Homicide Detective and the Medical Examiner said that **SHE WAS NOT RAPED**. The Medical Examiner said that there was **NO TRAUMA to HER GENITALS**. (SEE DNA MOTION IN WRIT AND PRO SE DNA MOTION). They also found numerous Finger Prints, some in blood, NONE MATCHING ME OR HER. They did not have a complete set of Jack Shadbolt's finger prints and the FBI said they could not check without a complete set. Seven days after she was killed, the Homicide Detective brought the husband in to get his statement. The Detective said he was very nervous and kept getting up and down. He had a "HICKEY" on his neck. When they asked him where he was at the time she was killed, he got up and said that he needed to go to the bathroom. Fifteen minutes later, the Detective goes looking for him. When he finds him, he says his Attorney was on the way. He arrived and they left. They arrested him for a hot check so they could question him, but he would not say one word. They told him that they knew that he did it and they would get him. They followed him and did everything but charge him for the crime. He did make some other incomplete statements, but none of this was brought up in my case. When you go through the WRIT and DNA Motion you will see how they did not tell the Jury anything. Withheld information and did not test anything. They also did not call any of my witnesses.

I did not get a Fair Trial. There is NO EVIDENCE that LINKS ME TO THIS CRIME. I had witnesses that could prove the things that I was telling them, but they just turned their heads. They finally, in my WRIT, got Affidavits from some of these witnesses. (SEE WRIT) They were NOT called to my trial. I had no chance to Prove My Innocence!

After I was charged, a girl that I had seen in many years, wrote the Detective she told them that I told her that I committed this crime 17 years ago. This woman is serving 4 Life sentences in the Federal Prison. She and the D/A told the Jury that there was no deal for her to testify and that she was Telling the Truth. After the trial, her sister Dee Dee Hughes, came forward and said that she told her that She Lied and Testified for a Deal.(SEE WRIT) Also, not long after she went back to prison, a girl Inmate wrote my Attorneys and said she had some information about my case. She wrote my WRIT Attorney that she was Tamara's "Cellie" and that she told her that She Lied to the Jury about the things she testified to and that she did it for a Deal. My Attorneys did not get an Affidavit from her and she has gotten out of prison. He said that he hired a Private Investigator to find this girl. Now he is saying that he CANNOT find this GIRL.

I NEED HELP! I have witnesses that can Disprove everything that they told the Jury, but no one seems to care about them.

I have DNA that needs to be tested. As you will see in the Writ and in my Pro Se DNA Motion. The Court will NOT Test these items. When they do get Tested, it will clear me and they know this.

I need a Finger Print Expert to look at these prints. They already clear me. I need an Attorney that will fight for me, not an Attorney that is PAID BY THE COURT. He will not go against the Court, because He is PAID by the COURT. He will NOT get anymore Appointments out of that Court, if he helps me. I have a lot more proof that I did not kill Michelle. I will be posting it soon.
