DEAR JIM :

Thank You for responding to my Sister's E-Mail about Cindy. Jim, it is very discouraging that we had a Witness, who could prove that Tamara LIED and Testified for a Deal. This is a BIG TIME BRADY VIOLATION and WITH HOLDING EXCULPATORY EVIDENCE. A DEAL TO TESTIFY. She wrote you numerous Letters about what Tamara, told her, and wanted you to make an Affidavit for her. Then she got out of Prison and then you wrote me and told me you were going to hire a P.I. to find her. I wrote you back and told you she should be on probation and maybe in a Halfway House. Did he look there? Is he still looking for her? If we cant find her, can we put her letters in my 11:071 WRIT? She has some information that only Tamara could tell her. You know Jim, it would not be so bad, but she is a Liar and she went back and told her friend that she lied and did it for a deal. This is my LIFE AND I DID NOT KILL ANYONE. I sit here on DEATH ROW and the Killer, JACK SHADBOLT, WALKS FREE. Will you PLEASE try to find this Girl and get her Affidavit.

Jim, there is a New Case House Vs. Tenn. It is a Supreme Court Case. It has to do with a second suspect. I think I was denied the right to bring Jack Shadbolt in as a second suspect, just like house. Do we need to Address this issue in my State Writ? And if we don't, WILL I LOSE IT?? The Homicide Det., Candy Randell, Lt. Gray, and others new that Jack killed Michelle. They told him it is in all of the Homicide Notes and in the Police Report from BOUNTIFUL POLICE DEPT., LT. GRAY. Will you look into this and let me know?

Jim on December 5, 2005, I filed a DNA Motion. Per 64.00-64.05. It was a Pro Se Motion. I asked if you could be Appointed to assist me. Not long after that, I received a letter from my Direct Appeal Attorney, LEORA KAHN. She stated that she had been appointed as my DNA Attorney. On January 9, 2006, I wrote the 180th. Judge Debra Mantooth Stricklan, stating that I could not except Mrs. Kahn, because I had just filed a "IAC CLAIM" on Mrs. Kahn. on October 10, 2005. In the 180th, In my 11:071 Writ, I advised Mrs. Kahn. She wrote me back on Feb. 20, 2006, asking me to drop the "IAC CLAIM" so she could represent me. I wrote her back telling her telling her I could not do this, and that I did not think you would let me. She stated that she would file a Motion to WITHDRAW, Due to CONFLICT OF INTEREST. On March 7, 2006, I received a letter with a Motion to Withdraw. I filed a Pro Se Motion, so why was she appointed? I was not there AGAIN at the hearing to remove her as my Attorney. I don't know if an Attorney was Appointed. It has been over a year and no one has contacted me. I went through a Liver Treatment for a year and stayed in the bed 24-7. I finished it on May 30, 2007. I did try to get some help through the court. On Nov. 9, 2006, I sent 3 Motions to the Court Clerk and the District Attorney, 1 for Stand By Counsel. I guess I am Pro Se????? I don't know, I need some kind of contact with the Court. One for a DNA Expert and One for the AUTOPSY. I have never seen it. I was NOT provided with it while Pro Se at Trail If im Pro Se I should get it.

Jim, I don't know if I am Pro Se or have an Attorney. I don't know if my motions have been ruled on or not. The reason I am writing you is because I don't know who else to write. The Court does not want to help me. All I am trying to do is PROVE MY INNOCENCE. Could you tell me if I am Pro Se or if I have an Attorney? If my Motions are still good, have they been ruled on and where do I stand? There is a new bill out on DNA Testing, House Bill 681. It lets trial courts order post-conviction DNA TESTING to answer unresolved questions about the case. MY WHOLE CASE IS UNRESOLVED QUESTIONS!
If this Bill goes into Law on Sept. 1, 2007, will you try to push my motion or yours to be ruled on?

JIM, THANK YOU FOR ALL YOUR HELP AND WILL YOU PLEASE LET ME KNOW ON ALL OF THESE ISSUES. THEY ARE VERY IMPORTANT TO ME.
