I am 37 years of age. I have never
been convicted of a felony or misdemeanor
offense, other than traffic offenses.
I am giving this statement to Jim Heitner
on September 30th 2005. I understand the
truthfulness of this statement is very
important. I have known William Swan
for 2^{1/2} years. I knew Michelle Sheekolt
for approx 7 months before her death.

Jamara Albert Thomas is my sister.
I have raised her children since 1995.

My sister Jamara & her husband
Larry Thomas ~~both~~ both went to the
Federal Penitentiary at the same time.

At the time of William Swan's trial
I was not contacted by ^{about} the trial by
any lawyers ~~any one~~. One day I was contacted by
Lisa Vatali and ask if I would be willing
to come to Harris County Courthouse. That
was the first time I was told that
William Swan was on trial for Capital
Murder. on the day she talked to me
she asked me if I knew, Tim Dorden, Georg Caldwell,
Joey Frey, Connie Summers, Billy Brady, Ponda Rinier,
Wade Mullins, ~~Robert~~ Nora, West.
I told ~~her~~ her what I knew about these people
and how to find them.

My first contact was by phone I was not contacted by any else until the trial. It was at the trial that I first learned about Tamara Testifying after the trial, after the trial I was told what Tamara testified about. The first time I was able to speak to her after she testified. We met to discuss what if she would let David Mullins her son to come time with my other sister Shanon.

Tamara called me over thru the Playy class to speak to me. All I said was "why don't you tell them the truth + she said + I quote "She can't its gone to far. later on a phone conversation Tamara told me that she testified falsely. In order to get her husband Larry Lamas moved closer. and later, but not much later, he was moved from Louisiana, to Fort Worth Tx. where Tamara also is in custody. Tamara also told me that Kelly Jeff Siegler was helping to get Duke University to work on her case. I also spoke to Ronda Riner who also informed me that it was Tamara's idea to helpfully help her, by lying on William.

I told, Gina ~~Valli~~ Vitalli the first time she talked to me, I told her about all the people that knew about William + Michelle.
